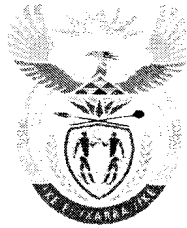

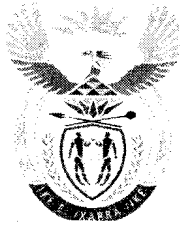

**ORDERED ON 19 JULY 2012**

1. The applicant is admitted as amicus in terms of SCA rule 16 and subject to its provisions.
